SENATE JOINT RESOLUTION NO. 101

A JOINT RESOLUTION

1 PROPOSING AN AMENDMENT TO SECTION 10, ARTICLE IX, OF THE CONSTITU-
2 TION OF THE STATE OF IDAHO, RELATING TO THE UNIVERSITY OF IDAHO
3 TO PERMIT THE BOARD OF REGENTS OF THE UNIVERSITY OF IDAHO TO
4 IMPOSE RATES OF TUITION AND FEES ON ALL STUDENTS ENROLLED IN THE
5 UNIVERSITY OF IDAHO AS AUTHORIZED BY LAW; STATING THE QUESTION
6 TO BE SUBMITTED TO THE ELECTORATE; DIRECTING THE LEGISLATIVE
7 COUNCIL TO PREPARE THE STATEMENTS REQUIRED BY LAW AND DI-
8 RECTING THE SECRETARY OF STATE TO PUBLISH THE AMENDMENT AND
9 ARGUMENTS AS REQUIRED BY LAW.

11 Be It Resolved by the Legislature of the State of Idaho:

12 SECTION 1. That Section 10, Article IX, of the Constitution of the State of Idaho be
13 amended to read as follows:

14 Section 10. STATE UNIVERSITY -- LOCATION, REGENTS, TUITION,
15 FEES AND LANDS. The location of the University of Idaho, as established by ex-
16 isting laws, is hereby confirmed. All the rights, immunities, franchises, and endow-
17 ments, heretofore granted thereto by the territory of Idaho are hereby perpetuated
18 unto the said university. The regents shall have the general supervision of the uni-
19 versity, and the control and direction of all the funds of, and appropriations to, the
20 university, under such regulations as may be prescribed by law. The regents may
21 impose rates of tuition and fees on all students enrolled in the university as autho-
22 rized by law. No university lands shall be sold for less than ten dollars per acre,
23 and in subdivisions not to exceed one hundred and sixty acres, to any one person,
24 company or corporation.

25 SECTION 2. The question to be submitted to the electors of the State of Idaho at the
26 next general election shall be as follows:

27 "Shall Section 10, Article IX, of the Constitution of the State of Idaho be amended to
28 permit the Board of Regents of the University of Idaho to impose rates of tuition and fees on
29 all students enrolled in the University of Idaho as authorized by law?"

30 SECTION 3. The Legislative Council is directed to prepare the statements required by
31 Section 67-453, Idaho Code, and file the same.

32 SECTION 4. The Secretary of State is hereby directed to publish this proposed constitu-
33 tional amendment and arguments as required by law.
