Dear Mr Hall,

Since at least 2004 I have observed the University of Idaho turning a blind eye toward professors, staff and students using the University computer system in manners that are not allowed under Idaho Executive Order 2001-12. My attempts to have the University discontinue the use of the University computer system for promoting local political causes and religious discrimination have been ineffectual.

In each occurrence the appointed University official stonewalled my requests. If the University took any action, it was limited and not long lasting in nature. This lack of enforcement encourages and allows further abuse of the University of Idaho computer system as evidenced by Tom Hanson's January 17, 20007 e-mail. Tom Hanson's Uoff computer accessed (hit) Right Mind over 31,000 times in 2006.

Requests for information from the University result in slow disingenuous responses or denial of the facts.

I request that the City of Moscow Prosecutor formally request the Idaho State Police investigate the use of the University of Idaho computer system. I request that this investigation use software and techniques to include recovering deleted files, data, other latent images and transmitted keywords. If the ISP does not have the appropriate software I will provide appropriate specialists to search under the ISPs guidance. I request that this investigation be started as soon as possible.

This request is made under Idaho Code 9-338 and others. The University of Idaho computers and computer system are public instruments and are open for inspection at all times with the exceptions listed in Idaho Code. The University of Idaho denies requests for student e-mail under Idaho Code 9-340A(1) and the Family Educational Rights and Privacy Act of 1974. However, the use of the University of Idaho computers or computer system for activity prohibited under EO 2001-12 is not protected at all. NoSuperWalMart.com and ZoneMoscow.com violate several areas of EO 2001-12 and the University of Idaho computer policy. In particular the use of the public system grants public access and I request that access now.

Tucows, Inc: (888) 511-4678 or hostmaster@ipowerweb.com If required follow up with an official letter.
- That the City of Moscow Prosecutor/ISP immediately contact PayPal to confirm or deny if any payments were made using the link on NoSuperWalMart.com. Again, preferably by electronic means with an official letter follow up if required.
- That the City of Moscow Prosecutor/ISP immediately contact the *Idaho Statesman* for full disclosure of Nick Gier's Reader's View published on Friday, August 12, 2005 to include a copy of the entire e-mail or other correspondence used to transmit that publication to the *Idaho Statesman*. Again, preferably by electronic means with an official letter follow up if required.
